The Dietrich Schaaf Conservation Fund is a nonprofit organization dedicated to furthering stewardship of the natural world. The purpose of this letter of inquiry is to gather information from impactful, grassroots conservation organizations or projects, and to provide financial opportunity to an entity that supports or extends our mission

Eligibility: DSCF will make funds available to support conservation based projects around the world. DSCF will NOT fund individuals; reimbursement of funds already expended; or political organizations.

Available Funding: The award amount is dependent on our fundraising season. There is no commitment by DSCF to fund any particular application or to make a specific number of awards.

Review and Award Information: Instead of a tedious grant application, we prefer to have shorter LOI submissions. All LOIs will be reviewed using the evaluation criteria as follows:

- 1. Consistency with DSCF's mission of furthering stewardship of the natural world;
- 2. Potential for positive impact within the ecosystem;
- 3. Internal and external organizational support for execution of the project, including experience of key personnel and cost-effectiveness of budget.

The date of funding is March 1, 2017.

Reporting Requirements: Projects awarded funding will be sent a Grant Recipient Agreement specifying the grant reporting requirements. Awardees will be asked to read, sign and date the contract, and return it to DSCF before funding will be sent.

LOI Submission Guidelines: Clearly explained projects may have a better chance in the review process. As much detail as possible will help us decide if your project is the one we would like to fund! Please lay out the following requested information and answers in a format of your choosing in a MS Word or PDF file. **The deadline for submissions is June 30, 2016**.
